

**IMPORTANT NOTICE – PLEASE READ: EXCLUSION OF LIABILITY –

THESE CONDITIONS AFFECT YOUR LEGAL RIGHTS**

1. By purchasing any ticket in the Jumpers Lane venue, or by entering the Jumpers Lane venue, you hereby acknowledge that you have read this agreement, understand the fact, nature and effect thereof and agree to be bound by its conditions. If you are purchasing a ticket on behalf of another person, you agree that you are making the purchase as their agent, thereby acknowledging that you principal is also bound by the conditions in this agreement, as if he/she has personally purchased the ticket.
2. You are entering these premises at your own risk. Right of admission is strictly prohibited.
3. Children under the age of 12 years are not allowed to enter these premises without adult supervision.
4. Jumpers Lane (Pty) Ltd trading as Jumpers Lane as the supplier of recreational services sells all tickets and supplies al recreational services and facilities including, but not limited to trampolining, trampolining lessons, rock climbing, dodge ball, paint ball and lazer tag in the jumper's lane venue subject to the following conditions:
 - 4.1 Jumpers Lane (Pty) Ltd trading as Jumpers Lane, their employees, directors, agents and affiliates have taken the utmost care in the maintenance, the condition, lay out, construction, design and the surrounding areas to ensure that it complies with acceptable safety standards.
 - 4.2 The use of trampolines, rock climbing, dodge ball, paint ball and lazer tag or the use of any other equipment at the jumper's lane venue involves a significant risk of participants suffering personal injury including the possibility of serious injuries, permanent disability or death. All participants who engage in such recreational activities do so at their own risk.**
 - 4.3 The customer acknowledges that the recreational activities are dangerous with many inherent risks and hazards and as a consequence personal injury and sometimes death can occur and the customer assumes and accepts all such risks and hereby waives the right to sue or claim against Jumper Lane (Pty) Ltd, their employees, directors, agents and affiliates for any personal injury or death in any way whatsoever caused by or relating to the customer and/or the participants participation in such activities.
 - 4.4 The customer acknowledges that even if the equipment and facilities on the premises are used in the prescribed manner, it may lead to damage, personal injury or death.
 - 4.5 Jumpers Lane (Pty) Ltd trading as Jumper Lane, their employees, directors, agents or affiliates are not liable to the customer and/or any participant, or their dependants for personal injury or death suffered by the customer or participant due to the recreational activities were not supplied with due care and skill or were not reasonably fit for their purpose of because of the negligence, breach of contract, statute or statutory duty by Jumper Lane (Pty) Ltd.
